Item 2. Educational and Business Experience

Woodward T. Odiorne, CLU®, ChFC®

Woodward T. Odiorne, CLU®, ChFC®, born in 1942, is a Senior Financial Consultant of Ellis Investment Partners, LLC. Woody is a 1964 graduate of Lafayette College, where he earned a Bachelor of Arts degree in Economics. Woody holds the Chartered Life Underwriter® (CLU®) designation, which he earned in 1971, and the Chartered Financial Consultant® (ChFC®) designation, which he earned in 1987. Both professional designations were conferred by the American College in Bryn Mawr, Pennsylvania. The CLU® designation is the highest level professional designation available in the insurance industry. The designation requires completion of eight courses designed to allow candidates to gain in-depth knowledge about the insurance needs of individuals, business owners and other professional clients. The ChFC® designation requires completion of nine courses, in key financial planning areas such as insurance, income taxation, retirement planning, investments and estate planning.

Prior to joining Ellis Investment Partners, LLC, Woody was associated with Capital Management Services, Inc. from April 2001 through March 2012, where he served as Senior Financial Consultant. He was also a registered representative of Equity Services, Inc., from March 1985 through April 2010, and of Comprehensive Asset Management and Servicing (CAMAS) from May 2010 through March 2012.
